MP Power Management Company Ltd., Jabalpur, MP Poorv Kshetra Vidyut Vitran Co. Ltd., Jabalpur, MP Paschim Kshetra Vidyut Vitran Co. Ltd., Indore and MP Madhya Kshetra Vidyut Vitran Co. Ltd., Bhopal (hereinafter referred to as the 'Petitioners' collectively or 'MPPMCL', 'East Discom', 'West Discom' and 'Central Discom' respectively), are wholly owned Companies of the Government of Madhya Pradesh. MPPMCL is the holding Company of the three electricity distribution companies (Discoms) of the State and has signed "Management and Corporate Functions Agreement" on 5th June 2012, with them. The petitioners have filed a petition before the Commission for determination of additional surcharge for open access customers purchasing power from within / outside the State of Madhya Pradesh in accordance with Section 42(4) of the Electricity Act 2003 read with Regulation 13.1 of Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Open Access in Madhya Pradesh) Regulations, 2005. In the petition, the petitioners have originally proposed to levy additional surcharge @ Rs. 1.27 per unit on the quantum of the electricity purchased through open access on the basis of the average month wise data. However, while substantiating the petition with the actual 15 minutes block data, the additional surcharge has been worked out by the petitioners as Rs. 1.02 per unit.
