**Circular**

In view of the provision given in the tariff order for FY 2015-16 for the recovery/adjustment of un-controllable costs due to increase or decrease in the cost of fuel in case of coal, oil & gas for generating plants through FCA charges. The CGM (RM), MP Power Management Co. Ltd., Jabalpur vide letter No. CGM(RM)/258 dated 27/06/2015 has intimated that on the basis of review of bills received from the generators for the preceding quarter the Fuel Cost Adjustment (FCA) charge to be billed by the Discoms to retail consumers during the billing quarter July'2015 to September'2015 works out to **32 paisa (Thirty Two Paisa) per unit.**

In view of above, FCA charge for billing quarter July'2015 to September' 2015 shall be billed uniformly to all categories of consumers as per the provisions of the tariff order.
